

SCIENCE FOUNDATION IRELAND AWARD TO A. STEW-ART FOTHERINGHAM

Professor A. Stewart Fotheringham has been awarded a highly prestigious Science Foundation Ireland Research Professorship with funding of 2.5 million euros (approx. \$2.8 million or £1.6 million). He will become Director of the newly formed National Centre for Geocomputation (NCG) at the National University of Ireland, Maynooth (NUIM). Under the current scheme, only 12 SFI Research Professorships will be awarded to attract world-class researchers to Ireland and they are restricted to the fields of Biotechnology and Information Communications Technology. The award thus recognizes not only Professor Fotheringham's contributions to academic research but also the growing importance of GIS and spatial analysis within modern society. The NCG will be housed in new accommodation at NUIM where there will be opportunities to host visiting researchers and post-doctoral students. The NCG will also have available a number of PhD Fellowships which will pay all tuition fees and provide a generous stipend. Anyone interested in visiting the NCG for any period of time is encouraged to contact Professor Fotheringham with their plans. MATTHIAS RUTH NAMED INAUGURAL ROY F. WESTON CHAIR IN NATURAL ECONOMICS

The University of Maryland, School of Public Policy has received a \$1.65 million gift from Roy F. Weston of Newtown Square, PA. to endow the Roy F. Weston Chair in Natural Economics. The gift also provides immediate start-up funding to launch a new initiative in Natural Economics, a field pioneered by Mr. Weston. The gift represents the largest contribution from an individual in the School's 22-year history.

Professor Matthias Ruth, chair of the Environmental Policy Program at the School, has been named the inaugural Roy F. Weston Chair in Natural Economics. Mr. Weston is the retired CEO of Roy F. Weston Consulting, now Weston Solutions, which he founded in 1957. The firm is among the leading environment organizations serving business and government in the areas of environmental remediation, redevelopment, and management.

The University anticipates that the Weston Chair will work in collaboration with the Institute for Natural Economics, an

independent nonprofit organization that Mr. Weston helped to launch. The Institute will serve as a center of information, research and learning about Natural Economics and work collaboratively with universities and other research institutions to explore best practices in environmental management, promote the integration of sustainable practices by private industry, and stimulate public-private partnerships.

AWARDS, PRIZES AND COMPETITIONS

19TH ANNUAL COMPETITION: THE CHARLES M. TIEBOUT PRIZE IN REGIONAL SCIENCE

The Western Regional Science Association is proud to announce the 19th Annual Competition for the Charles M. Tiebout Prize in Regional Science. The Tiebout Prize is awarded for the best paper submitted by a full-time graduate student enrolled at an accredited academic institution (currently, or during academic year 2003-2004). To be considered, papers should be in the general discipline of regional sciencetopics in the fields of regional economics, urban economics, urban/regional planning, geography, and local public finance are especially encouraged. Papers will be judged by a Reading Committee of former WRSA Presidents, and the decision of the committee (which will be rendered by late November) will be final.

The author of the winning paper must present at the WRSA's 44th Annual Meeting to be held at the Hyatt Regency Islandia, San Diego, California, during the period February 23-26, 2005. The winning author will receive \$1,000 to help defray the costs of attending the Meeting. The paper also will be published in the prestigious international quarterly journal The Annals of Regional Science (published by Springer-Verlag) following regular review procedures. Authors of all submitted papers judged by the Program Committee to be worthy of presentation will be invited to deliver them in regular sessions of the Meeting. Small travel awards may also be made to authors of papers judged worthy of designation for "Finalist" status in the competition.

Graduate students wishing to submit papers for the competition should send five (5) hard copies and e-mail as an attachment an electronic copy of the paper as a Word, WordPerfect, or PDF file in draft or final form to:

Deadline for Submission (hard copies of papers must reach WRSA by) is <u>October 15, 2004</u>.

All submissions must include a cover page giving the paper's title, author's full name, address, phone and fax numbers.

Please indicate your Department and University affiliation and the name of your primary faculty supervisor. Papers should be double spaced. Only one submission per author and only singly-authored papers will be considered. Any paper exceeding 50 pages in length will NOT be considered by the Reading Committee.

This prize is awarded in honor of the outstanding contributions to regional science made by Charles M. Tiebout before his untimely death in 1968. In addition to his scholarly achievements, "Charlie" Tiebout brought wit, irreverence, and goodwill to everything he did and everyone he knew. He was particularly good in advising, counseling, and encouraging graduate students: thus, it is fitting that the WRSA's annual prize bearing his name be awarded to the best graduate student paper in regional science.

BENJAMIN H. STEVENS GRADUATE FELLOWSHIP IN REGIONAL SCIENCE FOR 2005-2006

Graduate students enrolled in Ph.D. programs in North America are encouraged to apply for the Benjamin H. Stevens Graduate Fellowship in Regional Science, administered by the North American Regional Science Council of the Regional Science Association International (NARSC-RSAI). This Fellowship, in support of thesis research in Regional Science, is awarded annually in memory of Dr. Benjamin H. Stevens, an intellectual leader whose selfless devotion to graduate students as teacher, advisor, mentor, and friend had a profound impact on the field. Regional Science is a multidisciplinary field concerned with the theory and method of urban and regional phenomena. Regional Scientists use theoretical frameworks and methods of the social and other sciences, as well as develop new ones specifically for regional analysis and policy.

Eligible students should have completed all degree requirements except for their dissertation by the time the Fellowship commences. A requirement of the Fellowship is that the recipient has no duties other than dissertation research during the Fellowship, though the recipient may hold other fellowships concurrently. Applications from students working in any area or any Ph.D. program are welcome as long as their dissertation research addresses a question in Regional Science.

The Fellowship consists of a stipend in the amount of \$24,000 (U.S.), for a twelve-month period. Applications for the 2005-2006 Fellowship should be addressed to the committee chair, Professor Michael L. Lahr (address below), and postmarked by February 15, 2005. An application consists of five sets (5 sets) of the following materials:

1. A curriculum vita of no more than two (2) pages in length.

2. A statement in twenty (20) pages or less explaining the questions and issues to be addressed, the approach to be used, and the product expected from the thesis research. The 20-page limit is inclusive of references, but exclusive of tables and figures. This text should be in 12 point or larger font, doublespaced, with one-inch margins; references may be single-spaced.

3. The candidate's graduate transcript for all graduate study. Unofficial copies are acceptable. 4. A confidential letter from the thesis supervisor (plus four copies) sealed in one envelope, and signed across the seal by the supervisor. In the letter the supervisor should assess the quality and significance of the proposed dissertation research, specify the current state of progress toward the candidate's degree and provide a commitment by the thesis supervisor to obtain a tuition waiver for the candidate for the year of the Fellowship. A condition of the Fellowship is the granting of a tuition waiver for the year of the Fellowship by the host institution.

2ND REIMUT JOCHIMSEN PRIZE

In memory of its former president and in honor of the renowned economist Professor Dr. Dr. h.c. Reimut Jochimsen the Düsseldorf Regional Office of the Deutsche Bundesbank will award a prize for the best paper on the topic on "European Infrastructure Policy: the Infrastructure Policy of the European Community with Respect to the New Orientation of the Structural Funds".

This announcement is addressed to authors who want to participate in the search for possibilities of creating an economically efficient, socially fair and ecologically sound infrastructure for the European economies. To be considered, papers should not exceed 40 pages. The prize sum is 5.000 euros, which may be split up.

Papers should be submitted in a standard electronic form (PDF, PS, Word document; 12 pt./1,5 space) to Professor em. Dr. Walter Buhr, University of Siegen, 57068 Siegen, Germany, by <u>September 15, 2004</u>. Collaborators of the members of the Reading Committee may not participate in the competition.

The papers will be judged by a Reading Committee consisting of the President of the Düsseldorf Regional Office of the Deutsche Bundesbank and of three scholars formerly related to Professor Jochimsen.
